1. Purpose

- 1.1 Property and equipment, both initial allocations and items acquired over time, require regular maintenance and upkeep, and at times replacement. The cost of repair, maintenance, disposal, and replacement of physical property, plant, and equipment is the responsibility of the following budgets:
 - 1.1.1 Centralized department budgets (e.g. Facility Services, Health and Safety, Information Technology Services [ITS], Purchasing) are responsible for the cost of facility related systems, components, and equipment in their areas of responsibility, as noted in APPENDIX A.
 - 1.1.2 School basic budget is used to support elements of classroom education that are required by, and generally common to, all students. School generated funds are complementary and used to enhance the development of educational programs, and to support school initiatives and activities. School funds, encompassing school basic budget and school generated funds, are responsible for program related systems, components and equipment as noted in APPENDIX A.
 - 1.1.3 The items listed in APPENDIX A are for general referencing purposes and depending on the circumstance, and with discussion between the administrator and central staff, some costs may have an alternative or joint funding source.
- 1.2 Prior to altering any existing building components or sites, schools must obtain approvals following APM A5200 Repairs and Alterations to Facilities and Sites.
- 1.3 From time to time, special projects and initiatives (e.g. ministry funded initiatives, new school openings, school closures) will cover the cost (or partial cost) of various items that may or may not be listed in APPENDIX A.
