1. Results of the 2014-2015 Provincial Grade 9 Mathematics Assessment (PRO-I-1)

Superintendent of Program and Innovation Anita Simpson invited Deb Scharf, Manager of Research and Evaluation and Lori Beresford, Principal of Student Success - School Support Initiative, to the table. Manager Scharf provided an overview of the results of the provincial Grade 9 mathematics assessment, the trends over ten years related to the assessment results within this board and the province overall, and the differences in the results by gender. Manager Scharf reviewed several of the strategies and specific actions being taken to improve student results on the math assessment, including encouraging student use of the sanctioned learning tools while writing the provincial test.

Superintendent Simpson indicated that many students are not aware that part of their final mathematics mark is a based on their achievement on the math assessment. Superintendent Simpson stated that a multi-media campaign is being launched to let students know this and that they can use manipulatives and graphing calculators during the mathematics assessment.

Superintendent Simpson and Manager Scharf responded to trustee queries and comments related to how students choose their level of study and the transition process from elementary to the secondary panel for students. Following a request from a trustee, Superintendent Simpson agreed to include student median marks information on future reports.

Principal Beresford described the Middle Years Collaborative Inquiry (MYCI) program that provides staff with professional learning opportunities focused on mathematics in Grades 7-10 and supports improving cross-panel instructional capacity.

Superintendent Simpson responded to trustee queries and comments related to specialized mathematics teachers in the elementary panel, the impact of level of study on post-secondary pathways, de-streaming initiatives in the province, Parent Math Nights in elementary schools and the difference in math achievement by gender. Superintendent Simpson further responded to a question regarding mathematics achievement results in other countries as compared to Canada.

This report was provided for information.

2. <u>First Nation, Métis and Inuit Education Annual Action Plan 2015-2016 (PRO-I-2)</u>

Superintendent of Education Stuart Finlayson welcomed Lisa Ewanchuk, Principal of First Nation, Métis and Inuit Education (FNMI) and New Teacher Induction Program (NTIP) Lead, to the table. Superintendent Finlayson provided an overview of the Ontario FNMI Education Policy Framework and Implementation Plan 2014 that serves to guide the FNMI Action Plan.

Principal Ewanchuk presented highlights from the action plan that reflects a collaborative inquiry approach of infusing FNMI culture into the Ontario curriculum while enhancing teacher practices that benefit the learning and well-being of FNMI students. Some of the goals of the plan include using data to support student achievement, supporting students with transitioning, as well as engagement and awareness building of FNMI culture for all students in Simcoe County District School Board (SCDSB) schools.

Superintendent Finlayson indicated that Beausoleil First Nation is now running the operations at the Springwater Park and a program for students called Walking the Path has been created using a 12 km trail at the park.

Superintendent Finlayson and Principal Ewanchuk responded to trustee queries and comments related to the self-identification of students and the Summer Reach Ahead and Cultural Camp. Superintendent Finlayson offered to share a flyer regarding the Walking the Path program at Springwater Park with trustees.

This report was provided for information.

3. New Teacher Induction Program (NTIP) Annual Action Plan 2015-2016(PRO-I-3)

Superintendent Finlayson and Principal Ewanchuk provided highlights from the NTIP action plan that focuses on board and school level orientation, mentoring, professional development and training, and participation in the NTIP Teacher Performance Appraisal. The NTIP program supports year one and year two contract teachers as well as Long Term Occasional (LTO) teachers in their first or second assignment of 97 or more consecutive days.

Superintendent Finlayson indicated that there is a current focus on the professional development of French as a Second Language teachers of French Immersion, Extended French as a Second Language and Core French.

This report was provided for information.

4. Safe and Caring Schools Annual Action Plan 2015-2016 (PRO-I-4)

Superintendent of Education Daryl Halliday invited Principal of Student Success Heather Hamilton to the table. Principal Hamilton indicated that the Safe and Caring Schools Annual Action plan includes a proactive, preventative approach to maintaining safe, caring and inclusive learning environments for students. The plan includes the continued implementation of the Safe School Reporting Tool, the School Climate Survey for secondary students this school year, and a new guidebook entitled *Creating Positive Spaces; How Gay Straight Alliances (GSAs) Support All Students*.

Superintendent Halliday and Principal Hamilton responded to trustee queries and comments related to professional learning, safe school teams, access to the School Climate Survey and eLearning for Supervised Alternative Learning (SAL) students.

5. Relocation of Special Education Gifted Classes (PRO-I-5)

Superintendent of Education Chris Samis indicated that it is occasionally necessary to relocate specific special education programs in order to best meet the needs of the system and support all students. 





Christian Island Elementary School

Principal Johnson reported that once again this year Christian Island Elementary School hosted six teacher candidates from York University for one week during the month of May. The purpose of their visit is to observe and experience a First Nation School and community. The school has had some really nice teacher candidates come through our school over the years. They have also had success in recruiting some as either fulltime or as supply teachers.

It was another successful year for the Annual School Pow Wow. Students and staff worked very hard once again to host five hundred guests from the community and neighbouring schools. In addition to the drumming, singing, dancing, feasting, sharing and vendors, they also had:

- A gentleman from the community setup his skull and pelt display
- Anishinaabemowin Stories by Robert Munsch told in Ojibway by Mary Taylor
- Lost World of Reptiles
- Parks Canada Display
- Scholastic Book Fair

Among the special guests at the Pow Wow was Darci-que who is the author of the children's series, Mollie Doodle. Darci approached Principal Johnson this fall about writing a story about their school and community which they are very honoured and excited about.

On May 15th the Grades 4-8 classes attended the performance Spirit Horse which was hosted by ETFO. The students enjoyed the performance and it has sparked a lot of great discussions amongst staff and students.

This year they have been fortunate to have had a boys program offered by their local health centre. The program is called 2BBoys. The focus of the program is on the building of skills to help boys be the best they can be socially and emotionally. Some topics have included challenges; boys face (looking at media, sense of meaning in a boys world), emotions (learning to communicate in a way that works), self-talk skills, frustration, anger, rage, diversity, and building empathy (giving back). The program takes place during lunch, once a week for eight weeks. Initially the boys were reluctant to join and have since had a lot of fun. On a positive note, since this program has begun they have seen fewer incidents with this group of boys. A variety of strategies within the classrooms and the school yard have been tried. However, the 2BBoys program has had a positive effect on their behavior and manner in which they deal with certain situations.

This week students from the grades 2-5 classes are fortunate to be taking part in a series of free science workshops hosted by the Knights of Columbus. The workshops include simple machines and pulleys and gears.

Principal Johnson advised the committee that they are all excited as their choir has been asked to sing O'Canada at the PAN AM Torch Relay in Midland. Students have been diligently practicing their singing and drumming in preparation for this Wednesday. The students recognize how much of an honour this is and are grateful for the opportunity.

Two events the students are looking forward to during the last couple weeks of school is a "Fun Day" that the local Health Centre is hosting for students. During the last week of school, a school wide BBQ will be held at one of the beautiful beaches on Christian Island. The following day is the annual awards assembly and the last day for students. A nice way to end the school year for students, parents, community and staff!

Mnjikaning Kendaaswin Elementary School (MKES)

Evelyn Ball reported on behalf Principal Howard noting how quickly the academic year has gone and how it is the time to reflect on their successes this year and the areas of improvement for next year.

All students participate in the Orillia Kiwanis Music Festival. All classes perform as well as the Senior and Junior bands. Many MKES students chose to also do solos, duets and trios. Principal Howard was very pleased that this year they had a number of vocal solo's and the students performed the songs in Ojibwe. To celebrate their successes at the festival they had a Spring Concert that was very well attended by members of the community. The Senior Boys Drum Group has performed a number of times and is a wonderful representation of their school. Grade 7 and 8 students attended Aboriginal Camp Choice at Humber College. The opportunity to interact with Students from 5 other First Nations in a college environment is very rewarding for students. They were pleased to be invited to see a performance of 'Spirit Horse' arranged by the Simcoe County District School Board. Grade 6 students and staff from MKES hosted a Youth Teaching Youth Day for students from Uptergrove PS and Rama Central PS. This day gives the students the opportunity to share their culture and heritage with others. A number of students represented MKES and the CRFN at the Heritage Fair held at the Simcoe County Museum. All grade 6, 7 and 8 students chose an aspect of Anishnaabee culture, language or heritage and conducted an Individual research project. Principal Howard is pleased to report that one of their students won an award for her presentation on Wampum Belts and another student was selected to present her project - The Coldwater Narrows Land Claim in Toronto and was selected for the Young Citizen award.

One aspect that is continuing is to develop a healthy lifestyle for their students. They provide fruit every day for snack, run a Breakfast Club and twice per month provide salad and smoothies to students with the support of the Rama Health Department. The Health unit also ran a 'Healthy Lifestyle' poster competition with some great prizes. As part of a healthy lifestyle grade 6, 7 and 8 students had presentations on Internet Safety and the whole school was involved in the Safety Village initiative. The grade 5 class is involved in the D.A.R.E. project that was facilitated by Rama Police.

They celebrated World Autism Awareness Day and were very proud to display the flag at the front of their school. 6 York University student teachers who wanted to gain experience working First Nation students were hosted.

They are looking forward to First Nations Day, their Community Graduation, and the Graduation ceremonies for their SK and grade 8 students.

Lions Oval Public School

Principal Ewanchuk reported for Principal Halliday that last year their school council applied for a PRO Grant with a focus on bringing more families into their school including those from FNMI backgrounds. They were successful in their application and on May 13 and 14 they had FNMI storyteller Scott Debassigne share stories with all of their classes with a focus on the Four Elements. His storytelling and his way with students was wonderful and contributed nicely to their simultaneous creation of art murals with the same focus. Families were invited to bring in family photos to serve as the central core of the murals. The finished products are now proudly displayed in the front foyer of the school and have become part of a permanent collection. A wonderful school/community effort!

Twin Lakes Secondary School

Principal Toor reported that they are continuing to develop their FNMI program at Twin Lakes and students have been able to participate in some unique opportunities:

In April, ten of their First Nation students attended a full day workshop, *Our Voices Are Our Future*, at Geneva Park. Participating students enjoyed the message shared by David Jones and his organization, Turtle Concepts. The day focused on embracing culture and identity as a youth of the twenty-first century. Goal setting and planning your future, as well as team building were valuable activities students engaged in. Students were energized and left the workshop feeling more confident about themselves as First Nation, Métis and Inuit students.

Their Native Studies class also participated in the outdoor education program of St. Marie among the Hurons on June 1, which included an awesome game of lacrosse!

Three self-identified students travelled to Europe as part of an international exchange trip. One of our First Nations students laid a wreath at the Menin Gate in Ypres, Belgium, honouring the 4000 First Nation soldiers who fought in the Canadian Expeditionary Force in World War One, and helped defend the city. It was an unforgettable experience to see a classmate participate in the wreath laying ceremony, which included military personnel from Canada and around the world.

Grade 9 students in the SSSI classes have been preparing for EQAO testing. Classroom teachers and SERTs have been working together with students to ensure that students benefit from the use of appropriate accommodations. Self-advocacy has been a skill that students have been practicing through this process.

Twin Lakes Secondary School have 11 students graduating who are self-identified and 2 of those students are member of the Chippewas of Rama First Nation.

OD/Park S.S.

Principal Bauer reported that Lisa Snache and Sara Jamieson, FNMI Student Advisors, continue to support their 60+ self-identified First Nations, Métis, and Inuit students at OD/Park.

There will be 9 FNMI students who will be graduating in June as well as one who graduated at of the end of semester one; five have applied to a college or university of their choice, all have been accepted including one in the New Roads program for Indigenous youth at Georgian College in Barrie. They have been assisted with their applications for band funding as well as for other financial supports. Our other graduates are choosing to enter the work force or pursue an apprenticeship; they too are being assisted with transitional supports.

A cross-section of students, grades 9-12, were invited to participate in the Our Voices are Our Future conference at Geneva Park in April. Students were inspired by Turtle Concepts messages and vision and had a fantastic time participating in all of the hands-on activities.

The Chair of their Guidance department had the opportunity to participate in the two days of curriculum review hosted by the Ministry in Barrie in early May. This provided valuable insight into aspects of the new curriculum as well as a chance to network with other colleagues.

The grade 11 Native Studies class has been actively engaged in a variety of aspects of culture this semester. Authentic voices and activities were provided by the following guests: Roseanne

Mancari, Raven Cotnam, lan McCallum, and David Snake. Students also visited the Aboriginal Resource Centre at the Barrie campus of Georgian College where they had the good fortune of a teaching from elder Bernice Trudeau as well as a craft and a traditional meal. As the semester draws to a close, they are busy working on their final culminating projects. Each student has chosen another subject in the school in which to infuse cultural teachings. They are researching the necessary background information and then are designing the lesson(s) as well as providing an exemplar for their class.

Next year, there is sufficient interest to offer three sections of First Nations, Métis, and Inuit Studies – two sections of the grade 10 Open course as well as one section of the combined grade 11 College/Workplace course: World Views and Aspirations of FNMI Peoples in Canada. They also look forward to meeting our newest grade 9 self-identified students!

Midland Secondary School

Principal Fletcher reported that Midland Secondary School has a total of 74 FNMI students, 42 First Nation and 32 Métis who have self-identified. They currently have 17 FNMI students in attendance at 7th Fire.

In April, five 7th Fire students traveled to Geneva Park in Rama to participate in an amazing SCDSB wide FNMI Secondary Student conference about their role in shaping the future mindset of their communities. Students were enthralled with speaker David Jones, who focused his presentation on Turtle Concepts.

Students and staff members traveled to Beausoleil Island in May to visit the Georgian Bay Islands National Park of Canada. There they received an all-day lesson and interpretation from a First Nation Guide and Interpreter. Included in the lesson were the following: history and movement of First Nation people to and from Beausoleil Island, family histories including a tour of the graveyard, use of natural resources including a picking and tasting of wild herbs, natural birch bark dust as a 15 SPF sunscreen, how to throw an arrow using an Atlatl, lessons and handling of at-risk species of turtles and snakes (they even were lucky enough to have come across, catch and relocate a Massassauga rattle snake).

There were many notable happenings at 7th Fire this term. Lots of cooking for the Family Studies course has included comfort foods such as Indian Tacos, Scone Dogs, and a Métis inspired Fish Fry and other traditional foods. Community Reach donated funds to purchase two picnic tables which the students assembled. The YMCA Youth Entrepreneurship program provided a presentation resulting in six students partaking in the process of applying for grant money to start their own summer business. The students have participated in several healing and sharing circles. Many students assisted the GBNFC with the tanning and preparation of a moose hide in order to repair a large GBNFC community drum. The students are especially engaged in these initiatives as they learn about their history and current culture.

A number of celebrations of our students are occurring this spring. One student from 7th Fire is receiving the Midland Rotary Student of the Month for his outstanding work at 7th Fire, and another was recognized at the SCDSB Excellence in Education evening. We have 2 students graduating from 7th Fire. Both students are Beausoleil Island band members. Preparation for the

7th Fire Grad/Gala is in the final stages and will be held at Ste. Marie among the Hurons with all students and family invited to attend.

At Midland Secondary School, we have three Native Studies courses currently running with 54 students in the classes. In NAC1O, students have studied the art, history and culture of the Plains People. They learned about the impact of the arrival of the Europeans, the decline of the bison and loss of relationship, displacement, the Numbered Treaties, reserves and loss of sovereignty despite the courageous efforts of Chief Big Bear and Chief Crowfoot. They read "The Buffalo Rock" and "The White Buffalo Woman". Students have also studied the lifestyle, religion, traditions and art of the Eastern Woodland Hunters. They learned about wampum belts, dream catchers, Kitchie Manitou, Sky Woman and read the story of Windigo and the story of The Creation of Turtle Island. They learned about the courage of Chief Pontiac. They studied the art and achievements of notable artists - Norval Morrisseau, Daphne Odjig, Arthur Shilling and the contemporary work of Travis Shilling. Students learned about the impact of European settlers - disease, a new way of life, decline of the bison, displacement, land claims, reserves and residential schools. Students made dream catchers using seven points to refer to the seven prophecies and the seven grandfather teachings. They studied the Anishinaabe medicine wheel and the four sacred medicines. Using the Woodland style, they had to do a contemporary acrylic painting expressing their ideas of what they had learned since the start of the course. The first exhibition of NAC1O ART was at the QUEST Gallery at the Midland Cultural Centre at the HIGH ART '15: Our Future from May 1 to June 6, 2015. Students wrote an artist statement to accompany their totem poles in this curated show. Students have studied the Eastern Woodland Farmers and learned a few key facts of the Iroquois Wars. They learned about longhouses, the three sisters, False Face masks, their burial practices, the villages of the Wendat, and their displacement to Christian Island, Quebec City and to the United States. They read the story of Kitchikewana. In addition students briefly studied the lifestyle of the subarctic people and had to identify the languages that were still spoken during the 2011 census. They learned about the achievements of two notable politicians - Ovide Mercredi and Elijah Harper. They learned about the tragic history of the Beothuk and of the legacy of Shanawdithit. To finish off the course students are studying the Inuit lifestyle and art, inukshuks as well as Kenojuak's original art. They will read the Legend of Sedna the Sea Goddess. To finish off the course students are studying the lifestyle and art of the Métis and the achievements of Louis Riel. They will be introduced to the work of Christi Belcourt and will make a painted leather wallet inspired by the carrying bag of the Plains People and the floral beadwork of the Métis. Their second exhibition of their work is at our MSS Music, Arts and Drama night on June 10, 2015 which celebrates the work of our students in the Arts.

Grade 9 applied math classes completed two learning activities focused on integrating First Nation culture into math. Creating dream catchers with the FNMI student advisor, students used measurement and plane geometry theorems. The second activity was an outdoor education activity trip to Enaahtig Lodge where students participated in Indian Baseball, nature walks and cultural activities in addition to a linear relations activity involving archery.

In the Grade 11 course, NBE3C, the class read a First Nations novel together, and reflected on its themes and connections to our society. They are finishing a group reading project with various Aboriginal texts, which includes both collaborative and independent tasks. They are finishing up the course with participation in Project of Heart, a hands-on, collaborative project to honour residential school victims and survivors.

Penetanguishene Secondary School

Principal Fletcher reported on behalf of Principal MacIsaac that as the school year winds down the students and teachers had another eventful semester. Students enjoyed courses in languages, aboriginal literature and the arts. In addition students and staff benefitted from the opportunities to learn from Jennifer Noah and April Franks who visited PSS to provide their expertise and support in our journey to educate and support the PSS community of learners.

Contemporary Aboriginal Voices

Students have completed the short play "Someday" by Drew Hayden Taylor and discussed the impact of residential schooling and scoop up on our First Nation communities. Many were saddened and angered by the situation, it has given us opportunity to discuss changes that might take place. Students have also been encouraged to continue watching and listening to various media outlets about the Truth and Reconciliation Commission over the coming weeks and months, to continue educating themselves on how the circumstances of residential schooling is going to be rectified.

The short play, "Someday" also gave us the opportunity to talk about the various kinds of status that our First People have fought for. This in turn gave an opportunity to discuss some of the local treaties. Students also watched the documentary film "Club Native" which helped them to understand the difficulties associated with the Indian Act and status on Canadian Reserves. We followed up with a discussion about Waneek Horn-Miller's family and others being forced from the reserve for a variety of reasons. This generated heated discussion about the fairness or unfairness of reserve rules and the further impact that the Indian Act has had on our First Nation people.

The class also had the opportunity to have a guest speaker come in to talk about the impact of residential school on her own family. Students also asked many questions about the Seven Grandfather teachings and the various meanings of the Medicine Wheel.

Students participated in making our very own sage garden in the school courtyard. Students were invited to paint a rock that will be placed in the shape of a turtle around the sage. The students enjoyed a beautiful sunny morning outside reflecting. Finally, the class will be planting bulbs of the four symbolic colours later this week.

Native Art

The Grade 9 Expressing Aboriginal Culture class just finished looking at a Métis finger weaving and the importance of the sash and we also looked at Métis dot art. Students learned about dot art from Christi Belcourt, a Métis visual arts teacher and how she values the medicines of flowers and importance of studying nature. The class also has had guest mentors that held a two day workshop on drum making and their cultural importance. This has become a tradition at PSS and the students enjoyed it once again. Over the next two weeks the class will be looking at Eastern Woodland artist Norval Morriseau and how he wanted to bring back First Nations culture by creating teaching paintings. Known as the "Picasso of the North", he is one of Canada's best known First Nation artist and has achieved national and international acclaim.

The class will be finishing the year with a "pow wow" (party) and teaching each other drumming and dancing steps and eating traditional food.

Ojibwa Language

The Ojibwa language class has continued throughout the semester working on getting used to the Fiero system (Double Vowel System).

The students have been working on creating fun and interactive Anishinaabe games to help develop the pronunciation of key words associated with the Ojibwa language.

The class has focused on basic conversation pieces/sentences as well as personal pronouns, interrogatives, pejorative etc. Students have been learning different themes/groupings such as numbers, money, days of the week, animals and other items.

Overall, it has been a successful semester for students at PSS. The staff and students look forward to continuing the great opportunities to learn in their final year about the community that surrounds them.

Rama Student Advisor

Student Advisor Lisa Snache reported that she attended Parent-Teacher Interview Night at both TLSS and OD/PARK. Lisa met with students regarding mid-term reports, following-up progress and recommending strategies for success throughout the semester. Attendance was monitored for those students requiring additional supports, including parent meetings at school or home visits/phone calls. Lisa advised that she also met with students at the Simcoe Alternative Secondary School with Rama Youth Worker.

"A Day on Bay" was a field trip focused on financial literacy, budgeting and investing. Five students attended this trip that was hosted by the Junior Economic Club of Canada. The Club is also promoting their Bay Street Boot Camp in August.

Two students attended "Discover Science" which was held at Canadore College June 1 & 2.

Arlana placed at GBs May 21 for javelin and went on to OFSAA regionals May 28. Arlana also attended

prom, joined in link crew activities of cookies & cram and new recruitment. Arlana participated in a trip to the ROM (Royal Ontario Museum), Pride week, a student council BBQ, an athletic banquet, where she was the recipient of the Randy Kitchen Award - Excellence in Athletic Council leadership. Arlana attended the Arts banquet and the Thunderstar awards where she received an Award of Merit. Commencement rehearsals have begun. Arlana reported that TLSS is hosting elementary track & field events.

She also attended a Social Changemakers Regional Conference on April 28 in Alliston where participants address issues of discrimination and explore how to promote inclusion in their schools and communities. It offers a chance to further develop their leadership, teamwork, and critical thinking skills, beyond what is usually explored in their schools. The conference offered an opportunity to gain tools to create change in the issues they are most passionate.

Arlana notified the group that this will be her final meeting as she is graduating this year. She thanked the committee for the learning opportunities and experiences over the last three years, and added that she enjoyed her position as student representative.
