

Presenting at an SCDSB Board Meeting

Thank you for taking an active role in Simcoe County's public education process.

All Standing Committee, Board and Special Board Meetings are held at the SCDSB Education Centre in Midhurst (1170 Hwy. 26, across from the museum).

The public is invited to present at these meetings. These presentations are called delegations. Regular Board Meetings will hear up to 6 delegations at each meeting, with no more than 4 on the same topic.

Before you decide to present to the Board, make sure you have already tried to resolve your concern through staff, principals, superintendents, trustees or Standing Committees.

Regular Board Meetings

Board Meetings take place on the fourth Wednesday of each month. Public session begins at 6 p.m. and reconvenes at 7 p.m.

Business & Facilities Standing Committee

First Wednesday of the month at 6 p.m.

Program Standing Committee

Second Wednesday of the month at 6 p.m.

Human Resources Standing Committee

Second Wednesday of the month following Program.

All Board meetings are video-recorded and live streamed online at www.scdsb.on.ca. These recordings are archived online for future access.

How to request to make a delegation

All requests to make a delegation must be submitted by 1 p.m. one week prior to the meeting, and must include a copy of your presentation and/or outline of what the presentation will contain. Requests are reviewed in the order they are received by email or fax.
