Capital Plan

It is the policy of the Simcoe County District School Board (SCDSB) to provide a comprehensive range of educational opportunities equitably distributed across a broad and diverse geographical area through sustainable community schools, while ensuring the operation of schools occurs in an effective, efficient and economical manner. Capital planning is a continuous process where staff examine and propose strategies to address pressures associated with enrolment, utilization, facility condition and program delivery. The Capital Plan may recommend changes to attendance areas, the construction of new schools, additions to existing schools, the renewal/upgrading of facilities, or the commencement of accommodation or program reviews as required.

Since 2006, the SCDSB has reviewed accommodation and facility conditions with a long-term vision of aligning enrolment with capacity while also maximizing program opportunities. The strategies over the past seven (7) years have resulted in over \$213 million in capital funding for new schools, replacement schools, additions/renovations and to help facilitate school consolidations. As a result, the board is now able to concentrate efforts on accommodating new growth, student retention, programming and facility renewal. The Capital Plan 2018/2019 is focused on the following:

Capital Projects:

The 2018/2019 Capital Plan identifies capital projects currently under consideration for the three (3) year planning timeframe. Ultimately, business cases for approved capital priorities will continue to be developed and submitted to address enrolment pressures due to growth, school consolidation, and facility condition, ensuring schools are in the correct location and are of sufficient size to serve their communities.

Planning Reviews:

Attendance Areas Reviews, Accommodation Reviews and Program Reviews are reviews utilized to balance enrolment within a family of schools, to ensure programming meets the needs of the students, and to address facility pressures.

Schools and Property Matters:

Through the Capital Plan, recommendations are made to determine holding schools, schools closed to out-of-area students, surplus property, partnerships, and future school sites.

Supporting Data and Initiatives:

This document contains information and analysis as it relates to enrolment, programming, and the board's facilities. This information is the basis for the strategies and recommendations set out.









Section 1

Capital and Accommodation Strategies

Approved Capital Projects

The Ministry of Education funds capital projects taking into consideration the overall accommodation needs across the province. Annually, school boards are asked to prioritize their most urgent capital needs, and submit respective business cases in order to secure funding. Capital priority submissions were completed in August and September 2017, and in December 2017 and January 2018 the following capital priorities were approved:

When the Ministry announces the next round of Capital Priority submissions, the list will be evaluated and submitted, upon Board approval, based on stipulated Ministry requirements.



New Alcona elementary school

The Alcona community has experienced significant growth in student population over the past five (5) years and continues to grow, with an additional 4,193 proposed units expected to be built within a 10-year window, of which 1,885 units have received approval to begin construction.


The capital project under consideration is to construct a new 501 pupil place school in the south end of the community of Alcona in order to keep pace with the enrolment growth in the community. The following graph depicts the need for a new elementary school.



New Alliston elementary school

New residential growth in the Alliston area has been steadily increasing and will be ongoing. Currently, the schools in the community are over capacity, and projected to remain over capacity, with increasing reliance on portable accommodation. There are 1,300 units that have received approval and are either under construction, or soon will be. There are another 1,500 units draft plan approved and an additional 600 units being proposed.


The capital project under consideration is to construct a new 406 pupil place school in the community of Alliston. The new elementary school will enable the board to keep pace with enrolment growth. The following graph depicts the need for a new elementary school.



New Angus elementary school

New residential growth in the Angus area has been steadily increasing over recent years. Currently, the schools in the community are over capacity and projected to remain over capacity with increasing reliance on portable accommodation. There are 716 units that have received approval and are either under construction, or soon will be. There are another 320 units draft plan approved with an additional 1,000 units being proposed.


The capital project under consideration is to construct a new 357 pupil place school in the community of Angus. The new elementary school will enable the board to keep pace with enrolment growth. The following graph depicts the need for a new elementary school.



New Barrie #1 and #2 Southeast elementary schools Hewitt's Creek Secondary Plan

Under the Provincial Growth Plan, the City of Barrie is to grow to 210,000 people by 2031. Draft Plan applications have now been submitted for approximately 6,000 units in the Hewitt's Creek Secondary Planning Area. Growth schools are required in phase one (1) to accommodate a portion of the first phase of housing units with construction beginning in 2018. There are approximately 12,000 units being proposed in four (4) phases by 2031.


Two (2) new 501 pupil place schools in the southeast portion of the City of Barrie within the Hewitt's Creek Secondary Plan will enable the board to keep pace with the enrolment growth in this section of the City of Barrie. The following graph depicts the need for new elementary schools.



New Barrie #1 Southwest elementary school Salem Secondary Plan

Under the Provincial Growth Plan, the City of Barrie is to grow to 210,000 by 2031. Draft plan applications have now been submitted for approximately 1,900 units in the Salem Secondary Planning Area. Growth schools are required in phase one (1) to accommodate a portion of the first phase of housing units with construction beginning in 2018.


A capital project will be required to construct a new 501 pupil place school in the southwest portion of the City of Barrie within the Salem Secondary Plan. The new elementary school will enable the board to keep pace with the enrolment growth in this area of the City of Barrie. The following graph depicts the need for a new elementary school.



New Bradford secondary school

Building activity has been extensive in the past four (4) years within the community of Bradford. Currently there are 1,031 units registered and under construction. There are another 1,025 units draft plan approved, and 2,114 units being considered for approval. The board will experience continuous growth in the elementary and secondary panel from new development.


The capital project under consideration is to construct a new 798 pupil place school in the community of Bradford. The new secondary school will enable the board to keep pace with the enrolment growth in the community of Bradford and be able to accommodate the large number of students currently attending the elementary panel as they transition to secondary. The following graph depicts the need for a new secondary school.



New Bradford South elementary school

Building activity has been extensive in the past four (4) years within the community of Bradford. Currently there are 1,031 units registered and under construction. There are another 1,025 units draft plan approved, and 2,114 units being considered for approval.

The capital project is to construct a new 501 pupil place school in the south end of the community of Bradford. The new elementary school will enable the board to keep pace with the enrolment growth in the south end of Bradford. The following graph depicts the need for a second new elementary school.




New Orillia elementary school

The rural areas of Oro-Medonte and Severn Townships have had a significant shift in population. Rural communities such as Marchmont, Warminster and Cumberland Beach are all experiencing growth. As a result of this trend, rural schools which are on private services in this area are now at their accommodation limits. A new school in the western portion of the City of Orillia will be needed to help balance enrolment within these rural communities, as well as, accommodate the growth that is occurring within the western portion of Orillia.

Overall, there are 700 units that have received approval and are either under construction, or soon will be, with another 300 units receiving draft plan approval.

The capital project under consideration is to construct a new 357 pupil place school in the community of Orillia. The new elementary school will enable the board to keep pace with the enrolment growth and maintain the rural school populations at a level that meets their servicing and site limitations. The following graph depicts the need for a new elementary school.




Banting Memorial Replacement School

The Ministry of Education reinitiated the Building Condition Assessment (BCA) program of Banting Memorial HS in July 2016. Based upon the BCA, the report indicates that the current Facility Condition Index (FCI) is 31% with \$12,650,278 in renewal requirements over the next five (5) years. The report indicates that the replacement value of the school is \$41,311,990. The five-year window follows the same decline as was illustrated in the 2011 building condition assessment. This report further substantiates the board's long-term concerns with the Banting facility, and belief that replacement funding is urgently required to have the replacement building constructed prior to the need of extensive renewal work.

The board is requesting that the Ministry of Education fund the new replacement school as well as an EarlyON Child and Family Centre. The board is pursuing partnership opportunities to enhance community services.

The new school would replace an aging Banting Memorial HS which would ensure a long-term educational commitment to the community of Alliston. The following graph depicts the enrolment versus capacity of the proposed new school.




Hillsdale PS Addition

The rural area of Springwater Township has experienced shifts in population and as a result, rural communities such as Hillsdale are experiencing enrolment growth. Hillsdale ES, which is also on a private septic system, is now reaching its accommodation limits.


There are 507 units that have received planning approval. This development is expected to take approximately ten (10) years to build out. The subdivision is located adjacent to Hillsdale ES providing the board the opportunity to connect to urban services which will enable the board to expand the capacity of the school.

The capital projects under consideration is to construct a 118 pupil place addition onto Hillsdale ES. The new addition will enable the board to keep pace with the anticipated enrolment growth. The following graph depicts the need for the addition.



Tottenham PS Addition

New residential growth in the Tottenham area has been steadily increasing and will be ongoing. Tottenham PS has exhibited a slow enrolment increase in recent years. Based on census information, 700 recent housing occupancies, and childcare wait lists, the board expects to see significant intake in the primary division over the next 2-5 years. Currently there are 270 units registered and under construction and 465 units draft plan approved.



The SCDSB recognizes the importance of the quality of the learning environment for students. Factors such as changing demographic conditions, partnership opportunities, and the Ministry of Education funding model, affect the ability of the board to operate and maintain its schools effectively and efficiently to support student achievement. A review of these factors may result in the need to develop alternative solutions to student accommodation within a planning area or adjacent planning areas. There are three (3) types of planning studies the board may use when the above criteria needs to be addressed: Attendance Area Reviews (AAR), Program Reviews (PR) and Accommodation Reviews (ARC). The following table shows planning studies recommended to be carried out within the 2018/2019 school year.

Proposed Option:

Transfer the W.R. Best Memorial PS population to the new Oro-Medonte ps upon opening and maintain existing attendance areas. Relocate the French Immersion program from Forest Hill PS to W.R. Best Memorial PS to create a central single track FI school upon opening of the new Oro-Medonte ps.

Alternative Option:

An alternative approach would be significant attendance area changes involving additional Oro-Medonte and Springwater schools. Due to the potential scale of such changes, and in consideration of the Ministry of Education's Pupil Accommodation Review Guidelines, an Accommodation Review would be required. The guidelines require an accommodation review if greater than 50% of a school's population would relocate to a new attendance area. Given the population distribution currently within the Forest Hill PS, W.R. Best Memorial PS and surrounding areas, an attendance boundary review could potentially effect greater than 50% of the W.R. Best Memorial PS student population. Therefore an alternative recommendation would be to approve an Accommodation Review to commence in the 2018/2019 school year.

Recommendation:

That a program review be completed in preparation of the new elementary school.




Holding School Strategy:


Due to significant growth in Simcoe County, students generated from new subdivisions may not be able to be accommodated within local schools. Students from new developments may be directed to several schools to minimize over utilization. These subdivisions will be placed in an attendance area called a "Holding Area". Students will attend the named holding school until such time as a capital project is approved by the Ministry of Education resulting in an addition to the local school, or a new school is built within the community.

































Closed To Out of Area

Designating schools to be "closed" to all students who are not living within a school attendance area is a method used by the board to ensure stable enrolment and mitigate significant over utilization. There are five (5) main reasons the board "closes" schools to out-of-area students.

- 1. If a school or group of schools have been involved in a recent accommodation review or an attendance review.
- 2. If a school is being used as a holding school for a new school in which the board is seeking Ministry approval.
- 3. If a school cannot accommodate any further pupils as a result of septic system capacity.
- 4. If a capital priority approval results in the construction of a new school or a significant renovation/addition.
- 5. If a school accommodates a French Immersion or Extended French program, and is significantly over capacity.

The following forty-eight (48) elementary schools are proposed to be closed to out of area students for the 2018/2019 school year.

Facility Partnerships/Community Hubs

Cooperative and collaborative relationships between school boards and community organizations are part of the foundation of a strong, vibrant, and sustainable publicly funded education system, and it is the responsibility of all levels of government to make the best use of public assets. Confidence in public education and responsible stewardship of resources are supported by the practice of optimizing board resources through purposeful facility partnerships within the context of the board's responsibilities for student achievement, well-being of students and staff, safety, and pupil accommodation strategies. School boards are encouraged to reach out to community organizations on a regular basis to share planning information and to support effective planning with community partners.

Offering space in schools to facility partners can reduce facility operating costs, improve services and supports available to students, strengthen relationships between school boards, community partners, and the public, maximize the use of public infrastructure through increased flexibility and utilization, and provide a foundation for improved service delivery for communities.

Facility partnerships illustrate community commitment and help support business case submissions to the Ministry of Education. It is recommended that staff immediately initiate discussions with other public agencies and partners for the Capital Projects Under Consideration as outlined. Also note that it is the practice of the board to explore partnership opportunities for projects that may be outside of the three (3) year planning horizon and during the site designation and acquisition process.

Initial partnership discussions for business case submissions should occur by fall 2018 to coincide with Ministry of Education capital cycles.

Community and Demographic Trends

As part of the capital planning process, the demographics and residential development activities are reviewed and studied for each municipality. This analysis provides insight into the factors that impact existing enrolment trends, and also helps identify emerging trends that could impact future enrolment.

The existing population and future targets indicate the varying degrees of growth expected throughout Simcoe County, the City of Barrie and the City of Orillia. Community and Demographic Trends

As an extension of demographic analysis, staff track residential building activity. The information depicted below highlights the five (5) year building permit summary. The areas with the highest building activity coincide with the areas previously identified as municipalities where significant growth is expected. Building permit activity has a direct correlation to the overall population of each school. The number of housing starts within each school's attendance area determines if a school is declining, stable, or growing in population. 
Future Schools

Due to the extensive residential growth occurring in many communities, it is anticipated that additional schools, and/or additions to existing schools, will be required outside the three (3) year capital priority planning horizon. The following table identifies all areas where future growth pressures are expected, and indicates the number of school sites, designated, owned, or required (not yet designated or owned). Once able to be supported by a strong business case, staff will bring forward a recommended capital priority for schools required due to growth pressures. In some circumstances, the board may opt to release designated sites in the event they are not required due to demographic trends, or when alternative locations are desired due to phasing and development patterns. A priority for staff is designating and acquiring elementary and/or secondary school sites in the Alcona, Alliston, Angus, Bradford, and Wasaga Beach areas.


Enrolment

Student enrolment within the schools has a direct correlation to the creation of a learning environment which supports the board's mandate of creating life long learners. A strong student population in each and every school ensures stability of staff, programming, extra curricular activities, before and after school care and the efficient and effective use of public resources. The goal of the board over the past ten years has been to stabilize enrolment within each school. When student enrolment and school size are closely matched, the students, board, and community are well served.


Since 2006, the board has closed nineteen (19) elementary school buildings and built eleven (11) new elementary schools either within new growth areas, replacing older facilities, or "right sizing" the school within the community. Three new elementary schools have been approved by the Ministry with design beginning imminently. By 2018/2019 the board will have closed five (5) secondary schools, have opened two (2) new schools and be in the process of constructing two (2) new secondary schools.

By fall 2018, the SCDSB's elementary utilization will be 106%, while the secondary utilization will be 95%. By shifting school accommodation to meet enrolment, the SCDSB is in a favourable position to now concentrate on enhancing facilities and programs to benefit all students within every school.

The adjacent chart represents the projected elementary enrolment as it relates to capacity. It indicates that within the elementary panel, there are more pupils than available capacity indicating future capital priority needs.



The adjacent chart represents the projected secondary enrolment as it relates to capacity. It indicates that within the secondary panel, the enrolment and capacity are currently aligned.





The following enrolment charts highlight trends over the next ten (10) years, and are intended to provide a quick reference point of the overall comparison of pupils to the capacity of the schools in a geographic area. Where "Pupils Over/Under Capacity" is positive, there are more students than there is space. If the number is negative, there is more space than students.

Utilization rates are also included. These rates are calculated by dividing the number of students by the school capacity. A school is considered sustainable when the utilization rate is between 90% and 110%. Utilization rates outside of that range are monitored over the long-term to determine if accommodation strategies need to be considered. Portable numbers are based upon programmed space, not the number of portables on site.

Within the southwest elementary review area, there is significant decline in the southern schools, while the communities of Alliston and Angus are growing. A new school in Alliston will balance enrolment within this community, while the community of Angus continues to be over capacity. As indicated in Section 1—Future Planning Reviews, the southern portion of this region will be monitored to determine the appropriate strategy to meet the challenges of both declining enrolment and facility conditions.

Within the central elementary review area, schools overall, meet or exceed capacity. The majority of these schools are on rural servicing and need septic capacity solutions in order to maintain current student enrolment. Secondary:

Over the past four (4) years, the board has secured approvals of projects to address the needs of the secondary panel. These projects are enabling the board to "right-size" the facilities with the enrolment of the communities involved.

Growth within Bradford has placed pressures on the elementary panel that will be transferred to the secondary panel. A capital priority is being recommended to increase pupil places within this community.

Nottawasaga Pines SS is currently under utilized. Students generated from the Salem Secondary Plan development in Barrie will be held at Nottawasaga Pines SS until such time as a new secondary school is built in Southwest Barrie.

Banting Memorial HS has seen declining enrolment along with several of its elementary feeder schools over the past four (4) years. The facility condition of the building has now reached a critical level. Staff are recommending the replacement of the school.

Barrie South ss is nearing the final phases of planning approvals with construction anticipated to commence in spring 2018, with a proposed opening date during the 2020/2021 school year. The opening of the new school will alleviate the accommodation pressures at Innisdale SS. The Hewitt's Secondary Plan is expected to generate an additional 1,200 secondary students. The Salem Secondary Plan is expected to generate an additional 500 secondary students. A public secondary site has been designated in the Salem Secondary Plan.

Learning Centres:

The goal of the Learning Centres in the SCDSB is to provide customized and flexible learning environments for learners of all ages and abilities with a full range of opportunities to discover new knowledge, develop new skills, and to achieve personal learning goals. This investment in lifelong learning expands horizons, increases employability, and improves career options. The Learning Centres provide varied programming, including:

- secondary school credits for adults;
- high school diploma and preparation for post-secondary education for high school students;
- summer math program and international language programs for elementary students;
- parenting programs;
- international programs for newcomers; and,
- a personal support worker program.

There are campuses located throughout Simcoe County: Alliston, Bradford, Barrie, Collingwood, North Simcoe, and Orillia, with an overall enrollment of approximately 265 students, not including adult learners. Staff are currently studying the viability of a Learning Centre in Wasaga Beach.

Alternative Secondary Schools:

SCDSB offers alternative secondary school programs designated for students who have difficulty coping with large school settings, and who may benefit from small class sizes, one on one assistance, flexibility, and close relationships with the teachers. Students will receive help transitioning into:

- high school or adult learning centres for completion of their secondary school diploma;
- the workplace;
- apprenticeships; and,
- college.

There are campuses located throughout Simcoe County: Alliston, Barrie, Bradford, Collingwood, Essa, Innisfil, Midland, and Orillia, with an overall enrolment of 219 students.






Section 3

Programming

Programming ensures that students at all academic levels can achieve their maximum potential. SCDSB has an enriched variety of programming opportunities. Within the elementary panel, the board has implemented a French Immersion program, outdoor inquiry and leadership education, early learning initiatives, environmental strategies, and enhanced special education. Within the secondary panel a concentrated effort has been placed on upgrading and enhancing programming to align with technological advancement and market trends. These programming and partnership initiatives align with the Board's Strategic Priorities.



Early Learning Initiatives


Partnership Opportunities:

Child Care Centres:

There are twenty-one (21) child care centres located within SCDSB elementary schools and one (1) within the secondary panel. These centres serve children primarily from the ages of two (2) years until they enter Full Day Kindergarten. The ministry announced funding for new child care centres at: Chris Hadfield PS, Lake Simcoe PS, Pine River ES, Tecumseth Beeton ES, and New Bradford North ps which will serve infants, toddlers, and preschool children. Positive relationships with child care centres and the school help support seamless transition into the school system.

Before and After School Care:

All elementary schools currently offer before and after school care. Partnerships with child care operators have grown over the past seven (7) years, with the first year serving 260 children, to now serving more than 3,800 students within our system. The adjacent chart represents the distribution of students receiving care at our before and after school programs. Growth is occurring in the primary and junior grades.



EarlyON Centres:



The SCDSB has successfully partnered with the early years' agencies to provide service for families and children from 0 to 6 years of age. Programming, drop in centres, support groups, young parenting programs, screening, and medical services are among the programming initiatives occurring within these centres. Sunnybrae Public School is currently operating these programs. The Ministry announced funding for two new EarlyON Centres at the new Oro-Medonte ps and new Wasaga Beach ps.

As the Ministry of Education provides further guidelines for these hub initiatives, the SCDSB will be in a position to further support this much needed initiative.




French Immersion/Extended French

To meet the needs and preferences of students and families in Simcoe County, French Immersion was introduced in 2013. Uptake in the program has been significant, putting pressure on school utilization and English track programming. Over the past three (3) years, programming locations, dividing primary and junior/intermediate cohorts, establishing a single track program, and reallocating feeder schools, have been strategies used to help balance the demand of accommodating the program.

French Immersion and Extended French are now located within nine (9) geographic areas providing French programming opportunities throughout the county. Two intakes have occurred in the past, Grade 1 and Grade 5. The 2016/2017 school year was the last year for Grade 5 Extended French intake. The Extended French program will be phased out as French Immersion continues to be phased in.

Within the elementary panel, French Immersion programming is being offered to approximately 1,993 pupils, about 5% of the overall population. Attrition rates between grade cohorts have been minimal ensuring strong programming throughout each elementary grade. The Extended French program is being offered to approximately 1,326 pupils, about 3% of the overall population.



Indigenous Programming

Within the geographical boundaries of Simcoe County, there are two First Nation Communities, Beausoleil First Nation and Rama First Nation. Students from these communities often attend SCDSB schools. These students comprise some of the over 1,700 students in both elementary and secondary schools, who have voluntarily self-identified as being First Nation, Métis or Inuit.

The board supports the achievement and well-being of Indigenous students, while building cultural capacity and knowledge amongst all SCDSB students and staff. Our work is guided by the Ontario First Nation, Métis, and Inuit Education Policy Framework Implementation Plan. The plan cites four key strategies and actions:

- 1. utilize data to support student achievement;
- 2. supporting students;
- 3. support educators; and,
- 4. engagement and awareness.

In support of these strategies, the following education resources are in place:



- Principal of Indigenous Education
- Itinerant resource teachers
- Secondary staff allocation
- Special education resource teacher
- Alternative education program
- Ojibwe language instruction
- Indigenous student advisors
- Social worker support




Additional initiatives include: student leadership gatherings, student drum and dance groups; dedicated resource teachers in selected schools; Truth and Reconciliation Action Collaborative Inquiry; lunch and learns; administrative staff training; community gatherings; board wide implementation of a Land Acknowledgement, along with support lessons and videos; and the development of an Indigenous Heroes resource. These initiatives and community engagement are an important aspect of the on-going efforts to support student achievement and well-being.






Special Education

The Simcoe County District School Board's Special Education Plan focuses on inclusionary education practices to ensure that student needs are recognized and met through curriculum. teaching strategies, differentiated instruction, and learning environments that maximize opportunities and outcomes for all students. Student needs are addressed through programs designed to focus on individualized learning goals. To accomplish this, a range of supports and services are offered in students' home schools. For a small number of students with special education needs (SENs), consistent with parental choice, the school and area teams may determine a special education class placement provides opportunities for more intensive support and individualized instruction. This placement may include the learning centre in the student's home school or in a more specialized class located throughout the board. Elementary special education classes are specifically designed to support different instructional needs; Autistic Spectrum Disorder (ASD), Developmental Skills (DS), Gifted Program, Social Skills (SS), and Section 23. Within the secondary panel, congregated classes and/or programs have been developed to support differentiated instruction; Autistic Spectrum Disorder (ASD), Gifted Program, Life Skills (LS), Bayview Transition Centre, as well as, the Integrated Transition Support Program.





Special Education

The SCDSB provides supports and services to approximately 9,500 students, 87% in a regular class placement, through an individual education plan (IEP), to ensure students' educational and well-being needs are being met.

Special education programs and placement needs are regularly evaluated to align students' needs with program delivery. When relocating and/or consolidating programs, the following factors are taken into consideration:

- the number of students currently in the respective programs;
- the projected incoming number of students currently enrolled in elementary schools feeding into the programs;
- facility availability and program requirements;
- · staff qualifications;
- the home school location(s) of the students currently in the programs;
- distance travelled for students currently registered in the programs;
- the length of time the programs have been at their current locations;
- ensuring the receiving school has the staffing to accommodate the new program; and,
- ensuring the receiving school has the facility requirements to accommodate the new program (i.e. appropriate available specialized classroom space to accommodate programming and student needs).



Environmental Education

Environmental Education

The following policy initiatives are undertaken to support environmental education, teach environmental literacy and enhance the development of more environmentally responsible practices.

Ontario EcoSchools

The program was created to assist schools in implementing and complying with Acting Today, Shaping Tomorrow, a Ministry of Education policy framework for environmental education in Ontario schools. To achieve Ontario EcoSchools status, schools must carry out six (6) environmental initiatives:

- Teamwork and Leadership;
- Energy Conservation;
- Waste Minimization;
- School Ground Greening;
- Curriculum; and,
- Environmental Stewardship.



SCDSB has 57 schools applying to be certified as an EcoSchool through an annual certification process which assesses and recognizes their accomplishments. Selected elementary Ontario Ecoschools will participate in a pilot leadership retreat in March 2018 at the Tiffin Conservation Area.

Green Teams

Green Teams are important to the success of environmental programs and campaigns in SCDSB schools. They also play an important role in carrying out daily operations at schools, specifically recycling and organics collection from classrooms to centralized depot areas. All SCDSB sites are required to have a green team under the SCDSB Environmental Policy 2325. Elementary schools will be invited to display the accomplishments of their green teams at the annual Green Team celebration.

Environmental Investment Plan

The SCDSB offers schools an opportunity to receive funding for environmental initiatives through the Environmental Investment Plan (EIP). Schools can receive up to \$2,000 to pursue environmental programming (workshops, trips, etc.), small physical upgrades such as a water bottle filling station, school ground greening, or other "green" initiatives. The SCDSB funds \$30,000 worth of environmental projects through the EIP each year.

Active Transportation

Active transportation aims to reduce traffic congestion at the school and to increase the number of students who walk to and from school. It is important to understand barriers that inhibit students from walking to school and creating site-specific active transportation routes.


Facilities


With an inventory of over 6 million square feet, accommodating over 51,000 students, facilities must operate efficiently and consistently to ensure schools are open and available for student learning.

New SCDSB facilities feature the highest standards of the built environment achievable within the public system. Bright, comfortable and safe spaces provide optimum learning environments. To achieve this, emphasis is placed on building operation systems, spatial design, component upgrades and maintenance, renovations, additions, and new schools.


Building Information

Facility condition and program space have a direct correlation to the age of buildings. Throughout each decade of construction, buildings have a tendency to reflect different architectural eras and philosophies. Schools built in the 1960's were designed as small schools with large classrooms, bright windows, and minimal ancillary spaces such as gyms and libraries. In the 1970's, schools were designed to have open concept teaching, gathering areas, and an overall openness to them. Windows were minimized to mitigate learning distractions as well as to improve energy efficiency. Volume of construction also had an influence on the quality of buildings being constructed, with the 1950's and 1960's being fast growing construction years to keep up to the needs of baby boomers. As depicted in the charts below, the majority of SCDSB building stock was constructed in the 1950's and 1960's. Renewal and program retrofit needs are particularly high based upon the number of facilities now nearing 60 years of age.





The majority of SCDSB portables are between 30 to 40 years of age. Significant renewal needs are required to maintain this fleet. A portable renewal plan has been created with the expectation to surplus 20 portables in the next two (2) years, and begin a regimented maintenance plan for the remainder of the portables over the next five (5) years. This renewal plan is to ensure portables are safe learning spaces that meet the needs of educators and students.





Building Information

In addition to condition of buildings, septic and well systems servicing the rural schools face renewal concerns, as well as, limiting the enrolment permitted at each site. The board has begun metering flows to determine current levels of use. A conservation strategy has also been put in place to replace plumbing fixtures with low flush toilets and sensor taps to help reduce flows.

The schools below are those experiencing growth pressures and are at, or nearing, the operational capacity of the rural service systems. Staff are exploring servicing solutions at these locations.




Renewal

The overall age of the SCDSB building inventory, is directly reflected in the large overall renewal needs of the system's facilities. In the past several years, the board has been allocated approximately \$47 million to replace building components. The allocation provided is only able to rectify less than 16% of the overall renewal needs. Over the long-term, the board's five (5) year renewal needs are \$300 million dollars. The following charts represent the elementary and secondary five (5) year renewal needs. Within standardized building condition reporting, there are five (5) ratings placed upon a building to determine the overall life expectancy. The ratings range from good to prohibitive to repair (PTR), with PTR depicting the cost of replacing qualifying components is greater than 65% of the overall building. The SCDSB specifically concentrates on buildings with critical to PTR ratings and strives to determine how to best address the aging components of the building.

Currently, there is one (1) elementary school which has reached a prohibitive to repair rating, Shanty Bay PS. There are eight (8) elementary schools and four (4) secondary schools which have reached a critical to repair rating, including: Codrington PS, Couchiching Heights PS, Cundles Heights PS, Innisfil Central PS, Moonstone PS, Steele Street PS, Tecumseth South Central PS, Warnica PS, Banting Memorial HS, Collingwood CI, Stayner CI and Twin Lakes SS.

A significant number of SCDSB buildings fall within the poor rating, which ranges from 10% to 30% of the building components needing to be fixed or replaced. Every year, renewal dollars are strategically allocated to prevent system failure or safety concerns. As the board continues to align enrolment with school accommodation, facility condition becomes an increasingly important part of the overall accommodation strategy.







School Accessibility

The Accessibility For Ontarians With Disabilities Act (AODA) requires all public buildings within the Province of Ontario to be fully accessible by 2025.

The board has developed a simplified rating system in order to evaluate the accessibility of any given school. This evaluation assists board staff in determining at a high level what capital needs are required throughout the board to create a fully accessible environment. The rating system looks at five (5) main items: exterior site access, travel within the schools, barrier free group washrooms, single stall gender neutral washrooms, and the provision of a universal washroom.

Within the elementary panel, 45% of the schools achieve all five (5) requirements, while the other 27% need some capital improvements to meet accessibility standards. There are twenty-three (23), 26%, schools who need significant accessibility improvements, while two (2) schools, 2%, who meet few, if any of the accessibility components. School information is contained in Section 5—Elementary Planning Data—Accessibility.






Within the secondary panel, 39% of the schools achieve all five (5) requirements while 23% need some capital improvements to meet accessibility standards. There are five (5), 39%, schools who need significant accessibility improvements. School information is contained in Section 6—Secondary Planning Data—Accessibility. This summary currently excludes leased premises.

Funding for removing barriers and creating a fully accessible built environment has been provided through the board's annual renewal funding allocation. All major capital projects address every aspect possible of the accessibility requirements, including anticipating future updates to the Ontario Building Code. It is estimated that the SCDSB will only achieve 75% compliance by 2025 with the current level of capital improvements the board is allotted. It is hoped that the ministry recognizes the capital needs associated with fulfilling this mandate. Compliance will be monitored and if staff are not able to make significant progress with the current funding model, a capital priority will be submitted to rectify the schools where compliance requires a substantial capital cost.

Capital

Since 2007, the SCDSB has developed a comprehensive capital plan which has focused on pressure points within the system, specifically facility condition, program delivery, and enrolment/utilization. The primary objective of the capital plan is to match enrolment with the location of educational facilities, and ensure that facilities are aligned with up-to-date teaching practices. Since 2011, the board has secured \$213 million in capital funding. The following chart represents the capital funding received since 2011.



Within Section 1 of the 2018/2019 Capital Plan, the board identifies approximately \$195 million in funding needed for capital improvement from the ministry, including capital for additions, new schools, consolidation, and replacement over the three-year planning horizon.

Environmental Sustainability

Environmental Policy 2325

The SCDSB Environmental Policy was revised in November 2017 to reflect the impacts of climate change. The policy outlines the board's responsibility to take a leadership role in environmental awareness and action. Under the policy, the board has a commitment to sound environmental principles, reflected in its daily activities, decision making, and future planning. Utilities, energy conservation, waste management, and environmental education are practices carried out by the SCDSB that assist in the implementation of this policy.

Green Energy Act and Energy Conservation and Demand Management Plan

The *Green Energy Act* (GEA) Regulation 397/11 requires all public bodies, to publicly report their energy use. The second phase of the regulation was implemented on July 31, 2014, requiring public bodies to develop a five (5) year, comprehensive Energy Conservation and Demand Management (ECDM) plan. On June 18, 2014 the Board approved the ECDM prepared by Enerlife Consulting Inc. The five (5) year plan includes energy conservation measures, implementation costs, energy savings, and dedicated staff support implementation of the plan. In 2019, the SCDSB will be required to report back to the Ministry of Energy on the accomplishments to date on the ECDM plan submitted, as well as, further plans for energy reduction over the next five (5) year cycle.

Greenhouse Gas Reduction Fund

In April 2017, the Ministry of Education announced funding to school boards to reduce Greenhouse Gases through energy conservation projects. The SCDSB received \$2.6 million of funding which is to be applied to existing buildings that are planned to remain open for at least five (5) years, and all projects must be completed by March 31, 2018. The SCDSB has applied this funding to the ECDM plan projects. In total, there are 22 schools being retrofitted to increase energy efficiency through upgrades to the Building Automation Systems (BAS), mechanical retrofits, and 14 schools are receiving lighting retrofits to LED. These measures will result in \$500,000 per year in energy savings and \$600,000 in incentives from the utility companies.

Waste Management

The SCDSB currently participates in regular waste (garbage, recycling, and organics) collection through various collection authorities. Consistent waste practices, including education and collection, are necessary for reduction and diversion. Provincial waste legislation (*Waste Diversion Act* and *Waste Free Act*) and contractual partnerships and agreements require that all SCDSB buildings participate in any and all available waste diversion programs.



Environmental Sustainability

Energy Intensity Targets

A standards document outlining the energy performance criteria for lighting, mechanical, and Building Automation System (BAS) was developed as part of the Energy Efficient Schools program. These standards have been adapted for retrofit projects and new construction projects. Currently, less than 20% of SCDSB schools operate at these standards. The energy intensity targets are based on the actual performance data from the top performing existing SCDSB schools. These targets were developed to be aligned with the targets set out in the American Society of Heating Refrigerating and Air-conditioning Engineers' (ASHRAE) Advanced Energy Design Guide for K-12 schools, which aims to achieve a 50% energy use reduction, compared with ASHRAE 90.1-2004.

Independent Electricity System Operator (IESO) Feed-In Tariff Program (FIT)

The FIT program was developed to encourage and promote greater use of renewable energy sources including on-shore wind, waterpower, renewable biomass, biogas, landfill gas, and solar photovoltaic. SCDSB has 28 contracts under the IESO FIT programs. The array at Nottawasaga Pines Secondary School is owned and operated by SCDSB. It was funded through Renewable Energy Funding from the Ministry of Education in 2009 and installed at the time of construction. Previous efforts to get a FIT contract were rejected. The 50kW array officially started generating in October 2016. Bear Creek Secondary School has a 10kW micro FIT system owned and operated by the school. The system feeds the provincial Smart Grid. The remaining 26 contracts are part of a rooftop leasing agreement with Potentia Solar Inc. where they lease the roof area of 26 schools to generate 3.2 megawatts energy back to the provincial grid. The systems are owned and operated by Potentia Solar Inc. who receives the generation profits. In turn, SCDSB receives a leasing fee for the area of roof space occupied by the solar arrays. The funds are reinvested into the ECDM planned projects.











Southwest Elementary Planning Review Area




