- 1 - Trustee Lloyd has served as Chairperson and the Ontario Public School Board Association representative since December 2018, and as Vice Chairperson for 2016-17, and 2017-18 years.
 - 2 - Trustee North has served as Vice Chairperson since December 2018.
 - 3 - Trustee Beacock has served as Chairperson for the 2016-17 and 2017-18 years.
 - 4 - Trustee Locke served as the Ontario Public School Board Association Representative from 2012 to March 2018. Trustee Locke was replaced by Trustee Boswell in October 2019.
 - 5 - Trustee Hodgson resigned February 2017 and was replaced by Trustee North May 2017. Trustee Chandler resigned May 2017 and was replaced by Trustee Ley in June 2017. Trustee Clements resigned March 2018 and was replaced by Trustee Rafeek May 2018, who was then replaced by Trustee North in the December 2018 election.
 - 6 - Trustee DaSilva served as the Ontario Public School Board Association Representative from April 2018 to November 2018.
 - 7 - There are three students elected by the SCDSB Student Senate to serve as trustees each year.
 - 8 - Expenditures for 2016-17 includes \$1,954 related to fiscal 2015-16.
 - 9 - Up to an additional \$1,000 is provided to both the Chairperson and the OPSBA Representative in support of their additional responsibilities.
 - 10 - In the 2016-17 year an additional \$508 was incurred to host a trustee regional OPSBA meeting in Simcoe County. In 2019-20 the Board held a PD day for trustees at a cost of \$2,066.
- Travel expenses are largely impacted by the home location of the Trustee, the size of the area they represent, and whether or not they are a representative on a provincial organization.
